**ORDER UNDER SECTION 16A OF THE ROAD TRAFFIC REGULATION ACT 1984  
FOR THE PREVENTION OF OBSTRUCTION ON HIGHWAYS  
SOUTH CAVE 10K RUN  
VARIOUS ROADS, SOUTH CAVE**

On 21st July 2023 The East Riding of Yorkshire Council made a regulation under Section 16A of the Road Traffic Regulation Act 1984 which will be operative on 08:30 hours to 10:30 hours on 30 July 2023. The effect of the regulation will be:-

1. To prohibit any person from causing or permitting any vehicle to proceed along the following roads :-

<b>Length of road to be closed</b>	<b>Period of Closure</b>
<b>Church Street</b> – from Primary School entrance to Thornham Close <b>Church Hill</b> – from the junction of Thornham Close to entrance of Cave Castle <b>West End</b> – full extent between the entrance of Cave Castle to junction with Pinfold <b>Pinfold</b> – the full extent <b>Annie Med Lane</b> – the full extent <b>Water Lane</b> – the full extent <b>Ellerker Lane</b> – extending south from Water Lane to junction Willow Flats <b>Common Road</b> – from the junction of Ellerker Lane to junction of Millbeck Bank <b>Millbeck Bank</b> – the full extent <b>Norfolk Bank Lane</b> – the full extent <b>Ings Lane</b> – from the off road public footpath that joins to Norfolk Bank Lane to junction of Main Street, Ellerker <b>Main Street, Ellerker</b> – full extent <b>Howden Croft Hill</b> – between the junctions of Ings Lane and Mill Hill <b>Mill Hill</b> – the full extent <b>Cave Lane</b> – the full extent <b>Stonepit Road</b> – the full extent <b>Willow Flats</b> – between the junctions of Stonepit Road and Ellerker Lane	08:30 hours to 10:30 hours - these closures will operate as rolling road closures and roads will be reopened once the race has passed consistent with maintaining public safety

2. The Order will not extend to emergency vehicles.
3. The Order shall not prevent at any time access for pedestrians to any premises situated on or adjacent to the said lengths of road, or to any other premises accessible for pedestrians from, and only from, the said lengths of road.
4. The East Riding of Yorkshire Council (On Street Parking Places) (Civil Enforcement) (Consolidation) Order 2021 is hereby suspended for the lengths of road listed in the Schedule for the duration of this Order.
5. The Regulation may be examined during normal office hours from the date of this Notice until 30th July 2023, at Brough Customer Service Centre, Petuaria Centre, Centurion Way, Brough, HU15 1AY, and Beverley Customer Service Centre, Cross Street, Beverley HU17 9BA.
